GREEK AFTERNOON SCHOOL COVID-19 POLICIES & PROCEDURES IN ACCORDANCE WITH CDC & DOE GUIDELINES

- 1) Modified drop off/pickup procedures to eliminate congestion to take place in the Church where students will wait with their respective class in assigned pews that have been marked according to social distancing guidelines, as well as staggered dismissal times;
- 2) Drop off to begin at 3:45pm to allow adequate time for temperature check upon arrival, assembly in the Church and travel to classrooms in order for classes to begin on time;
- 3) Multiple entrances and exits to be accessible during drop off and pickup to control traffic flow;
- 4) Mandatory mask wearing by all students, parents, faculty and staff. Masks will be available if needed;
- 5) Proper spacing between students and desks in the classrooms. If there are too many students enrolled in a grade than can be accommodated in a classroom, another section will be created;
- 6) Hand sanitizer dispensers/bottles will be available in every classroom. Students are encouraged to have their own bottle of hand sanitizer as well;
- 7) Classrooms, bathrooms, and shared spaces to be cleaned and sanitized before and after each Greek Afternoon School session;
- 8) No shared water bottles or snacks during Greek Afternoon School sessions;
- 9) Proper signage to remind students, parents, faculty and staff to follow CDC guidelines;
- 10) Parents are responsible to monitor their child's health to make sure they do not have fever, cough, shortness of breath, sore throat or any other COVID-19 symptoms, as well as conduct wellness check of their child prior to each Greek Afternoon School session, including temperature check;
- 11) Parents to advise Greek Afternoon School if their child's day school closes due to COVID;
- 12) Students, parents, faculty and staff should not attend a Greek Afternoon School session if they exhibit one or more of the following:

- (1) COVID-19 symptoms in past 14 days;
 - (2) positive COVID-19 test in past 14 days; and/or
 - (3) close or proximate contact with a confirmed or suspected COVID-19 case in the past 14 days;
- 13) Travel Advisory: In response to increased rates of COVID-19 transmission in certain states within the United States, and to protect New York’s successful containment of COVID-19, the State has joined with New Jersey and Connecticut in jointly issuing a travel advisory for anyone returning from travel to states that have a significant degree of community-wide spread of COVID-19. The travel advisory is effective at 12:01 am on Thursday, June 25, 2020. If you have traveled from within one of the designated states with significant community spread, you must quarantine when you enter New York for 14 days from the last travel within such designated state, provided on the date you enter into New York State that such state met the criteria for requiring such quarantine. The requirements of the travel advisory do not apply to any individual passing through designated states for a limited duration (i.e., less than 24 hours) through the course of travel. Examples of such brief passage include but are not limited to: stopping at rest stops for vehicles, buses, and/or trains; or lay-overs for air travel, bus travel, or train travel. The travel advisory requires all New Yorkers, as well as those visiting from out of state, to take personal responsibility for complying with the advisory in the best interest of public health and safety.
